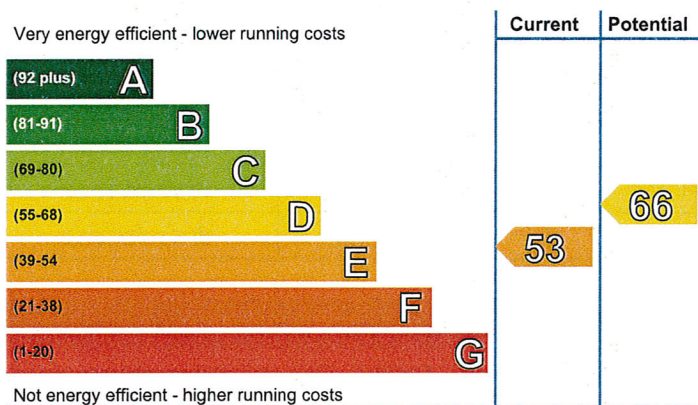

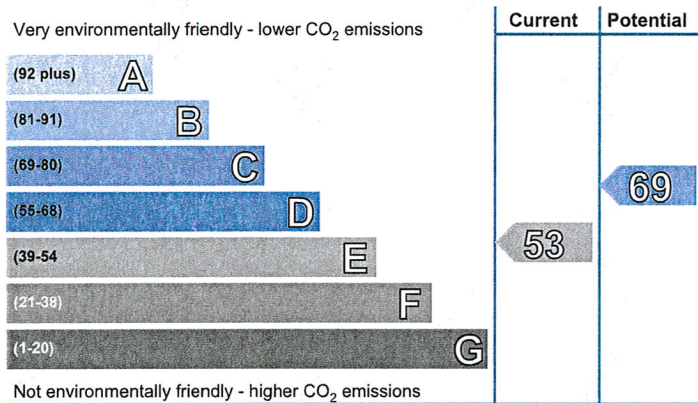


## Energy Efficiency Rating
