#### Introduction:

Steadfast Gas Services Ltd has prepared this report after carrying out Portable appliance testing (PAT) of electrical appliances and equipment to ensure they are safe to use.

#### **Disclaimer:**

The tests undertaken at the indicated address were carried out on parts of the building accessible to the Tester. Areas may be inaccessible because they were locked, no safe & clear path was available, access was expressly denied by resident/tenant (if applicable inaccessible areas will be recorded below)

#### Portable Appliance Testing Explained:

Portable appliance testing (PAT) is the term used to describe the examination of electrical appliances and equipment to ensure they are safe to use.

In Scotland, Landlords are required by law to ensure that the electrical installation in a rented property is safe when tenants move in and maintained in a safe condition throughout the time tenants are resident in the property. **To meet these requirements** a landlord will need to have **basic safety checks** regularly carried out, to ensure that the electrical installation and appliances are safe and working.

**NOTE:** Portable Appliance Testing carried out only applies to appliances provided by the Landlord & expressly does not cover electrical items brought in to the premises by the tenants/residents/or others. **The safe function of these other appliances is the entirely the responsibility of the tenant/residents.** 

**Further,** it is the responsibility of the tenant/residents to make all appliances **supplied by the Landlord** available for testing when requested to do so. Appliances not made available for testing will be reported as **failed** and costs of further visits to test these appliances may be chargeable to the tenant.

Steadfast Gas Services Ltd test portable appliances based on the **Health and Safety Executive**'s recommended intervals as defined in the HSE publication "Maintaining portable electric equipment in low-risk environments" (see table on page 5 here: <u>http://www.hse.gov.uk/pubns/indg236.pdf</u>)

### **Declaration of Liability:**

The appliances listed in this report MUST be tested as part of this PAT report. A PAT Test is required to evaluate the electrical safety of these appliances.

If Tester has been unable to access areas, items in these areas <u>cannot be tested</u>. (including, but not limited to, fire risk & electrocution risk of the items).




