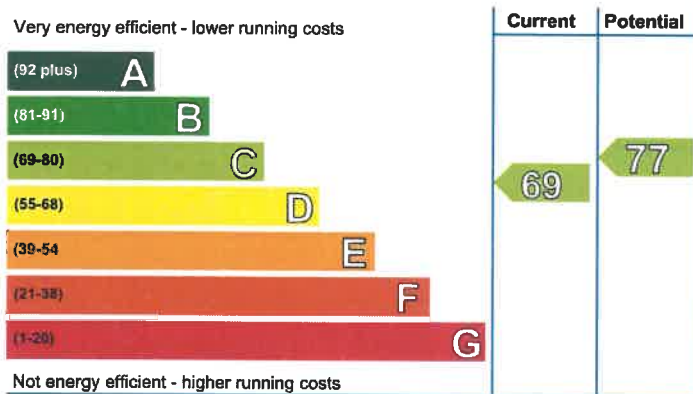

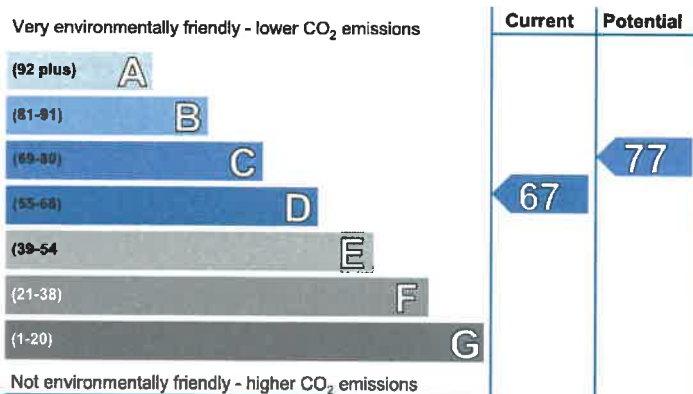


Energy Efficiency Rating
