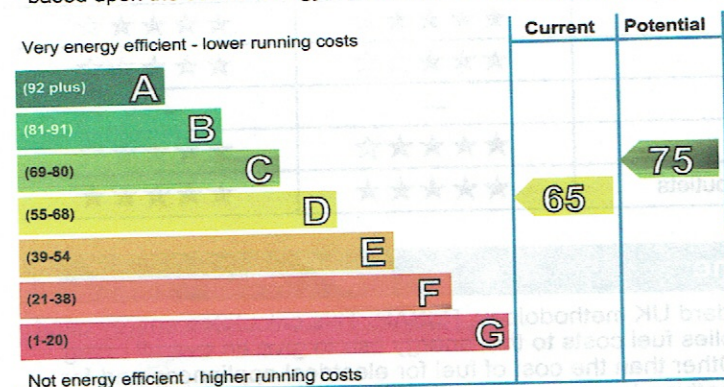

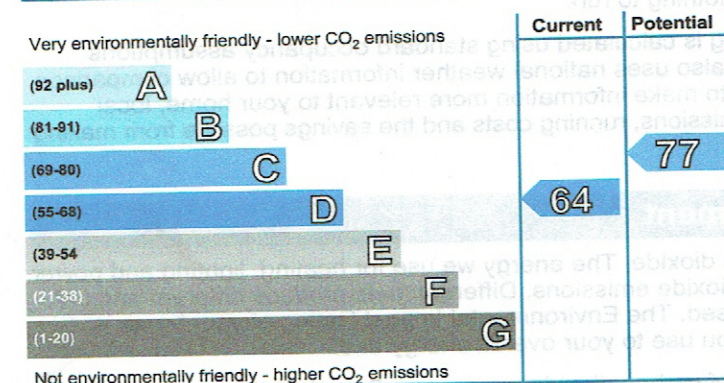


Energy Efficiency Rating

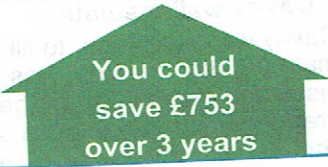
