



Thermal transmittance is a measure of the rate of heat loss through a building element; the lower the value the better the energy performance.

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, SAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 0.9 tonnes of carbon dioxide every year. You could reduce emissions by switching to renewable energy sources.
